# 6. Clinical Procurement in Partnership Award

This award recognises an individual or team who has introduced a new innovational project or change in practice or product into their organisation resulting in significant improved patient outcomes, clinical engagement or supplier relationships.

The individual or team must demonstrate how they have transformed business/clinical practice through implementing collaboration/engagement to implement change.

This may include some or all of the following:

- How the project has resulted in new ways of working to improve patient outcomes or supplier relationships
- The purpose, aims and objectives of the initiative and why it was implemented
- Impact and results the approach has achieved which could include:
  - o effects on productivity
  - o efficiencies
  - o cost savings or value-based outcomes
  - o culture change /changes in working practice
  - o improved patient outcomes
  - o increased clinical engagement
  - o Social Value, Sustainability and environmental improvements
- How you plan to develop or sustain the work

Nominations for this award are not restricted to members of the HCSA and can be made on behalf of anyone working at any level in the health care purchasing and supply function.

The nomination must be proposed by a member of the HCSA.
